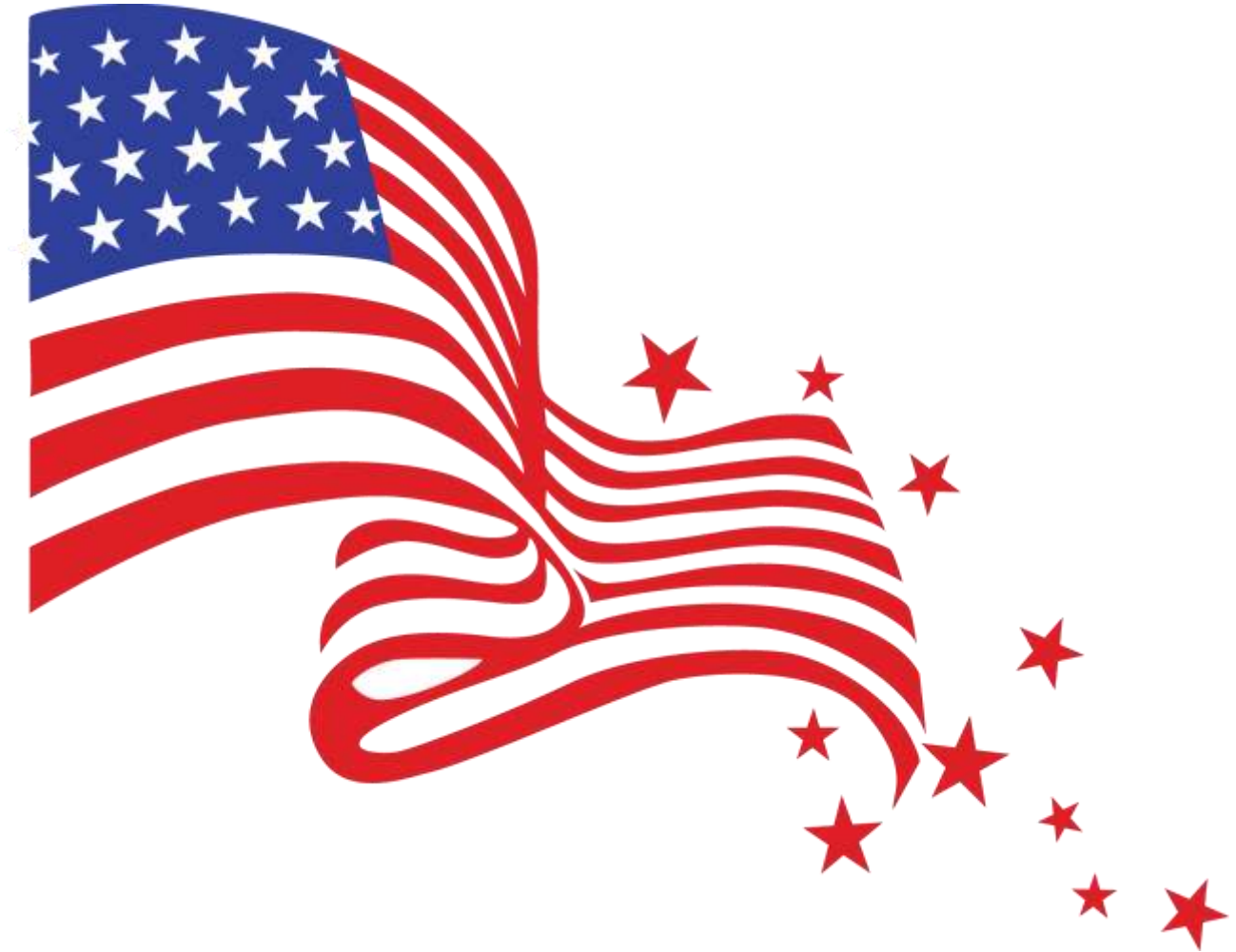

Filing Information City & School 2017

Deadline to File– June 1st 12:00 pm with County Election Office

Requirements to File for ALL Offices

- Must file at County Election Office
 - o No longer able to file with City Clerk
- Must File by **ONE** of the Following:
 - o File by Fee
 - \$20.00 Payable to Wabaunsee County Election
 - o File by Nomination Petition
 - Details listed below
- Candidates Must Complete **ALL** of the Following:
 - o Declaration of Intention
 - o Statement of Substantial Interest
 - o Affidavit of Exemption

Filing by Petition for City Offices K.S.A. 25-2110

(set by ordinance of each city)

- Alma – 5% qualified electors signatures = 32 Signatures
- Alta Vista – 2% qualified electors signatures = 8 Signatures
- Eskridge – Two (2) qualified electors signatures
- Harveyville- Two (2) qualified electors signatures
- Maple Hill – Five (5) qualified electors signatures
- McFarland – Five (5) qualified electors signatures
- Paxico – Five (5) qualified electors signatures

Filing by Petition for School Board Member K.S.A. 25-2020

(Number of signatures set by law)

Fifty (50) qualified electors' signatures in member district

-or-

10% of qualified electors signatures in member district, **whichever is less.**

- **USD 330** – Voting Plan B (Vote by District in Primary and Vote by Large at General)
 - All Positions = 145 Signatures
- **USD 329** - Voting Plan C (Vote by District in Primary and General)
 - Position 4 = 45 Signatures
 - Position 5 = 40 Signatures
 - Position 6 = 42 Signatures

- June 1st: Filing and Withdrawal Deadline (12:00 noon) and Deadline to Question to be placed on Primary Election Ballot
